# A Message from Joe Shorokey



What a difference a year makes! The changes to Ohio's behavioral health system in 2018 were unprecedented, and as was true for all licensed providers, it required much of our focus during the past year. Ohio's "Behavioral Health Redesign," coupled with the implementation of "Medicaid Managed Care" for behavioral health services, brought incredible challenges to clinical, billing, credentialing, IT, supervisory and management staff. Fortunately, because of the dedication and expertise of all of these staff, we have successfully weathered the storm and are continuing to thrive.

These challenges didn't come and go without changes. I'm very proud that our organization and its staff are innovative, nimble, and through foresight, able to make the difficult but necessary adjustments to remain successful. Alta Behavioral Healthcare made changes to our nursing services, provision of group therapy, physician services and documentation, among others. We also initiated new services including certifications in Mental Health Day Treatment, Intensive Home Based Treatment, and Peer Recovery and Support Services. Respite Care was also initiated and will continue to grow with a new population, as Alta was certified as a Waiver Provider by the Ohio Department of Developmental Disabilities and Medicaid.

Other highlights for the Behavioral Healthcare Division were the renovation of the Camp Challenge Social Hall, the expansion of our partnership with the Mahoning County District Board of Health to address infant mortality, and the piloting of a new program to provide emergency crisis response to schools for youth experiencing an emotional crisis.

Alta Head Start was also quite busy during the past year. Most prominent was the successful completion of the first Federal Review of our program, which resulted in not a single finding. We also completed a conversion that allowed for the expansion of available Early Head Start slots for an additional 16 children. Our Head Start Program also began a pilot program in 2018 that included the placement of a Therapeutic Behavioral Support Staff in several classrooms. The program will help us implement positive behavioral interventions with some of our most challenging children. This pilot has been successful and will be more fully implemented in 2019.

Finally, I would again like to thank our many partners and supporters in the community, many of whom can be found on the last page of this report. Without the partnerships of schools, hospitals, physicians, courts, funders and too many others to mention, we could not make the impact we do!

#### **Program Performance Summary Report**

The Administration for Children and Families (ACF) conducted a Focus Area Two Monitoring Review of the Alta Care Group, Inc. Head Start and Early Head Start programs from April 19-23, 2018. The report contained information about the grantee's performance and compliance with the requirements of the Head Start

Program Performance Standards or Public Law 110-134, Improving Head Start for School Readiness Act of 2007.

Based on the information gathered during this review, the Head Start/Early Head Start programs were found to have met the requirements of all applicable Head Start Program Performance Standards, laws, regulations and policy requirements.

## Parent Engagement

- Several parent meetings included mini child development trainings, which gave parents educational activities to complete with their child as well as a better understanding of the development of their child.
- Parents were given several opportunities for parent education through the Incredible Years Parent Education Program that was offered three times a year; Triple P Seminars and Triple P Discussion groups; and the Ohio State University Extension Parent Nutrition Education program.
- Throughout the program year, parents were provided the following engagement activities. Many parents took advantage of these opportunities, which resulted in more parent engagement. All events provided education for parents and children:
  - The Green Team Recycling program, Home Fire Prevention, Car Seat Safety, Pedestrian & Bus Safety
  - Use of library services, parent/child home projects, Weekly Reader Parent/Child Homework Interaction
  - Father/Daughter and Mother/Son Dance, Dad's Spare Time for Bowling, Egg Hunt, Sock Hop Dance
  - Bedtime Rituals, Child Abuse and Neglect, Father's Rights, and two Farmers Markets.
  - Parents were provided with Education, Mental Health and Nutrition learning activities to do with their child throughout the school year.


# 2017 - 2018 Behavioral Health Client Demographics













#### **Head Start**

Head Start is a comprehensive child development program which serves children age three

to compulsory school age. The overall goal of Head Start is to increase school readiness and social competence in young children in low-income families, helping them to meet the kindergarten readiness goals. Our Head Start programs as well as other Head Start programs in Ohio have their education curriculum in alignment with State Pre-K Standards.

Children participate in a variety of educational activities that reflect best practices in early childhood education. The program strives to create a learning environment that develops cognitive, social, emotional and physical skills. The program encourages parents to engage in their children's learning development as well as accomplishing their own goals.

## **Early Head Start**

Designed for children 0-3 years of age, this full-day, full-year program provides enrichment

and sensory stimulation to their minds, preparing them for the learning process in either a center-based option or a home-based option. Unique to this program are services to pregnant women, providing them with support and education to assist them on their journey to motherhood.

The mission of the Early Head Start program is to:

- promote healthy prenatal outcomes for pregnant women
- enhance the development of very young children, and
- promote healthy family functioning

In Early Head Start we support early bonding and attachment in the child-parent relationship and child-caregiver relationships. Once the children turn 3 years old, they transition into our Head Start program.

### **School Readiness**

The Alta Head Start Program prepares children for kindergarten by providing them

the opportunities to learn in group settings, ensuring they are socially and emotionally ready for kindergarten. A total of 372 children transitioned into kindergarten at the end of the 2017-2018 school year.

To prepare these children and families, several activities were provided. The activities included:

- Field trips to the local kindergarten classrooms
- Kindergarten Transition Event that provided the families with local kindergarten registration information
- Quarterly transition materials that were shared with the families

Wipfli, LLP, an independent public accounting firm, conducted an audit of the combined financial statements and programs of Alta Care Group, Inc. The firm, in its opinion, found that the financial statements presented fairly, and in all material respects, the financial position as of June 30, 2018 and 2017 and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States. In the firm's report of compliance for Major Federal Program and on Internal Control Over Compliance, it found, in its opinion that Alta Care Group, Inc., complied, in all material respects, with the types of compliance requirements that could have a direct and material effect on its major federal program for the year ended June 30, 2018.

Children's developmental outcomes were assessed throughout the school year utilizing the Teaching Strategies Gold (TSGold). The TSGold is an ongoing observation system that the program uses to assess children ages 6 weeks to 5 years old. The following table is a reflection of the results for those 372 children who are transitioning into kindergarten.
