#### **General Responsibilities**

Delivery of school readiness supportive/consultative services to parents of young children.

#### **Specific Essential Functions of the Job**

1. Training and Consultation

- Provide home based services to families with the goal of increasing protective factors and adopting new behaviors to strengthen the family unit and mitigate risk factors for child abuse and neglect.
- Administer screening tools/assessments, analyze results and develop related interventions.
- To learn and use evidenced-based parent programs in the delivery of parenting education.
- Serve as a Family Coach to develop a prevention services plan, outlining the families' goals and will utilize evidence-based programming to enhance the families' protective factors and increase the family's stability.
- Provide parenting programming and facilitate access to Like Skills training, as well as Family Coaching, which will incorporate Motivational Interviewing to assist the family in moving towards behavioral change.
- Administer and review universal screenings for families.
- Collaborate with evaluation staff to facilitate and support the completion of the updated needs and resource assessment for the project and to adhere to evaluator guidance on evaluation/assessment administration.
- Be responsible for ensuring data collected and documentation of services is consistent with rules and regulations and requirements of program evaluation.
- Serve as point of contact for the county of service.
- Submit regular programmatic and fiscal reports to the
- Administration for Children and Families, Youth and Families Children's Bureau, as well as to other identified partners requesting data.
- 2. Record Maintenance
  - Develop a Consultation Checklist and Action Plan for each consultation service location, collect all required data pieces as necessary for program evaluation and reporting purposes. Enter all data pieces into Alta or funding source web-systems as required.
  - Securing necessary releases of information to perform duties related to the position.
- 3. Support to the Agency
  - Assist the Clinical Director and/or Department Coordinator in collecting and compiling objective data so as to accurately assess success of services as they relate to targeted service outcome goals.
  - If appointed, serve on the Continuous Quality Improvement Committee.
